

UCI GRADUATE STUDENT RESEARCHER(GSR) CHILD CARE REIMBURSEMENT FOR UAW-REPRESENTED STUDENT EMPLOYEES

Submit your completed form to your hiring department personnel office.

If you are a UC Graduate Student Researcher (GSR), GSR Fellow, and/or GSR Trainee represented by the UAW, use this form to request reimbursement of your eligible child care expenses under the system-wide Child Care reimbursement program. To be eligible, GSRs should have a minimum position of 25% time for the fiscal quarter. If your GSR Fellowship or GSR Trainee offers reimbursement equal to or more than program limits, you are ineligible for this program, and requests should be made directly to the funding grantor.

A child care provider must have a valid tax Identification or Social Security Number. Appropriate receipts must also be provided.

Deadline

Reimbursement requests for expenses must be submitted after the expenses are incurred. Reimbursement requests should be submitted via this form based on campus specified deadlines but **no later than the last day of the following term.**

A qualified dependent is a child in the custody of a GSR who is age 12 or under on July 1st. Effective Winter 2023, the reimbursement limit is **\$1,350 per fiscal quarter**. Effective October 1, 2023, the reimbursement limit is **\$1,450 per fiscal quarter**.

Payments under this program are subject to Federal, State and FICA taxes, if applicable. Federal tax withholding will be 25 percent and state tax withholding will be 6 percent.
